



## 2025 Equity Homeowner Golf Options

Sunrise equity homeowners, through their monthly dues, enjoy unlimited access to all the recreational and social amenities and opportunities Sunrise has to offer, except for the golf course. Even so, there are several ways for equity homeowners to enjoy rounds of golf as outlined below:

**Annual golf membership:** 2025 Annual Equity Homeowner Membership: \$3600 - \$3900 (single), \$5500 - \$6235 (couple). Includes children under age of 21 years. The higher price includes use of club-owned carts, the lessor includes a trail fee for a private-owned cart or walkers. Tee times can be made 5 days in advance.

**Equity homeowner rounds:** All equity homeowners are permitted *ELEVEN* (11) rounds per year even if not joining at any golf membership level. You must pay the current guest fee (2025 - \$70 for 18 holes; \$45 for 9 holes), which includes use of a golf cart. To use your equity rounds, each time you make a tee time identify yourself to the golf shop as an equity owner. Your account will be charged per use. If you wish for a family member or friend to use any of the rounds, you must nevertheless make the reservation under your account and physically accompany them on the course. Tee times can be made 3 days in advance.

**Additional golf membership options:** *equity homeowners may play a maximum of eleven (11) rounds per year unless they purchase an additional short-term membership. Equity homeowners may NOT play additional rounds as the “guest” of a golf member. Guests are defined as non-residents of Sunrise Country Club.*

There are several **membership options** to consider depending on the intervals you spend at Sunrise. All memberships provide unlimited golf for the time period of the membership. These are non-transferable.

Memberships may be purchased through the HOA Administrative Office at the following 2025 rates: (use of club-owned cart included)

- One month: \$1,100 single, \$1,800 couple
- Two months: \$2,100 single, \$3,400 couple
- Three months: \$2,950 single, \$5,000 couple
- Four months: \$3,800 single, \$6,000 couple
- Five months: \$4,500 single, \$6,900 couple
- Six plus months: \$4,800 single, \$7,600 couple
  
- Summer Membership (May 15 – September): Rates to be determined.

**Walking Carts:** A limited number of walking carts are available to borrow at no cost.

### **Golf Guest Policy**

1. During the season (Nov. 1 - May 31), a guest of a golf member may play golf a maximum of (6) times. Exceptions will be made for family members who live outside the Coachella Valley and for out-of-town guests who are visiting or staying with a member.
2. During the summer (Jun 1 – Sept. 30), a guest of a golf member, including a summer season golfer, may play once (1) per week by paying the appropriate guest fee.
